## Session Descriptions

### **Restorative Justice:** MO Restorative Justice Coalition

Restorative justice is a new way of orienting crime and harm that focuses on identifying and repairing the harm to the victim, holding the offender accountable, and involving, to the extent possible, all those affected in developing a response. Restorative justice is increasingly being used around the world. Come hear about this evolving area of practice.

### **Roundtable Discussions:** Clerk Panel

Bring any forms you use and look at other forms used in different courts. Attend this session to help answer your questions or just “vent” a little with our panel. If your court has a “problem” area then chances are one of the panel members has also had the same problem, so come discuss your issues and we will help resolve them with you.
