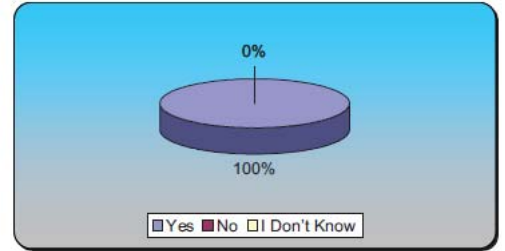

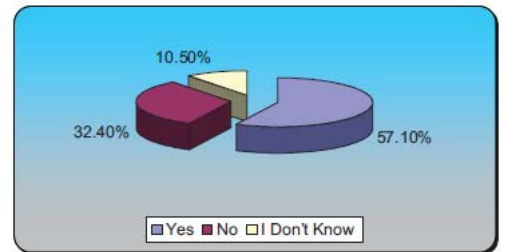
1.) 1- A non-English speaking defendant is charged with DWI/DUI, they have no driving privileges in the US, is the Judge required to order SATOP?

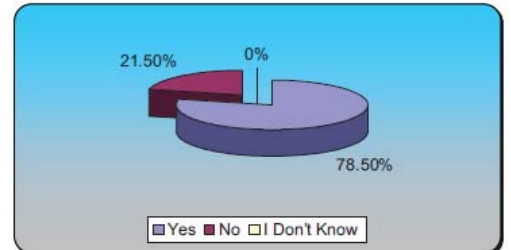
2.) 1- A non-English speaking defendant is charged with DWI/DUI, they have no driving privileges in the US, is the Judge required to order SATOP?

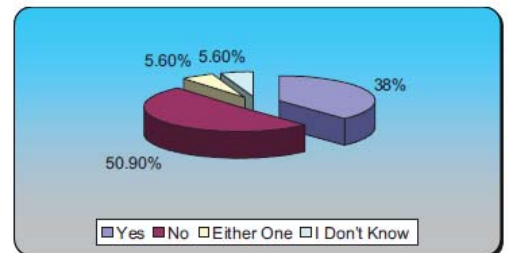

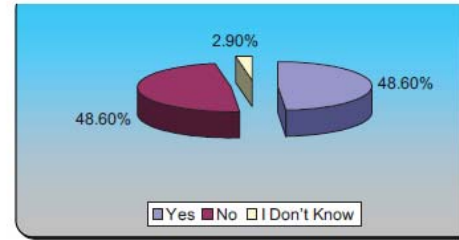
4.) 3- Defendant files for trail de novo after the 10 day time limit. Do you send to application, bond, filing fee to the Circuit Court?

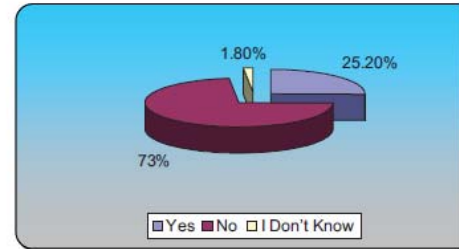
5.) 4- A defendant wishes to attend an internet traffic school to avoid points. May they attend?

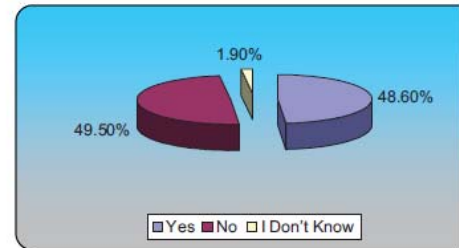
6.) 5- A defendant receives a citation for improper turn in a personal vehicle, they do have a CDL endorsement, may they attend a traffic school to avoid points?

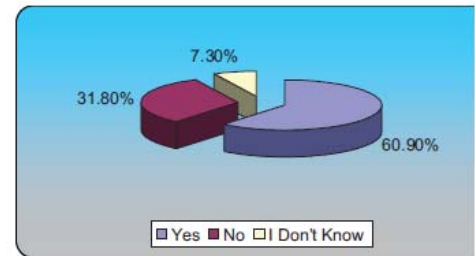

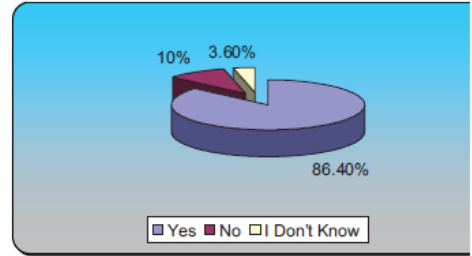

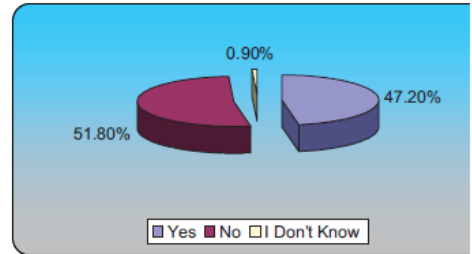

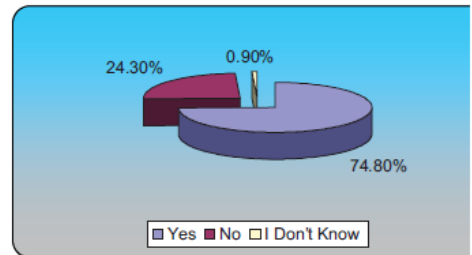

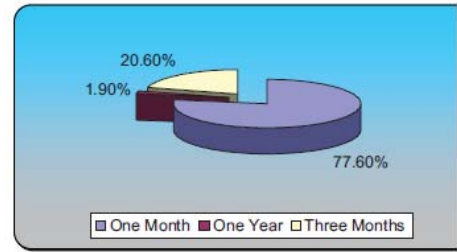

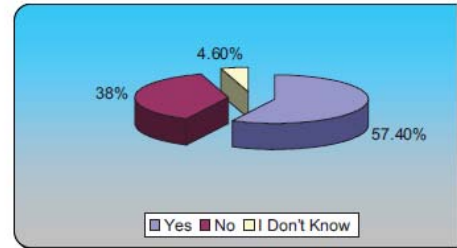
15.) 14- What is the minimum term of insurance one must produce to show proof of financial responsibility?

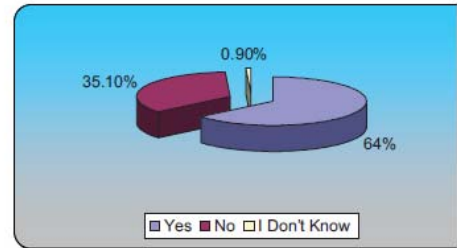
16.) 15- Does Missouri law permit courts to impose an additional surcharge for "administrative costs" for taking a credit card in payment of a fine/costs or bond?

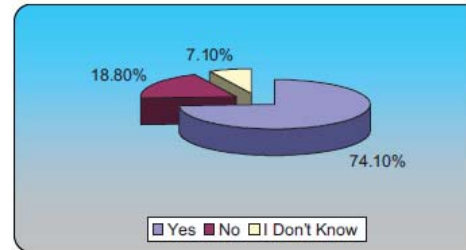
17.) 16- Can the Judge issue a failure to appear warrant for the single charge of No Seat Belt?

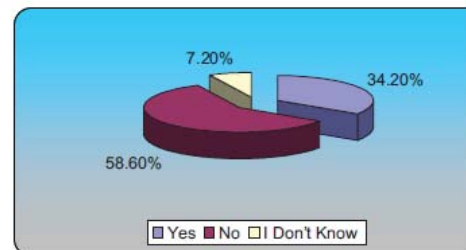

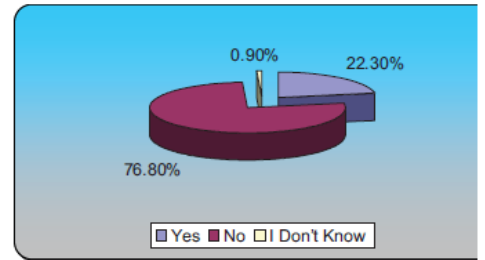
